2. The guest and Morse student must check in together and show a valid picture ID when entering the dance. There will be NO NAME CHANGES and NO TICKETS sold at the door.
3. Morse student and guest must arrive at the dance by 9:30pm.
4. You must attend the dance until 11:30pm. There are NO EXCEPTIONS. Supervision ends at 12 midnight. Please have your rides scheduled for prompt pick-up.
5. You must wear proper attire at all times. The Homecoming Dance is a SEMI-FORMAL dance. Morse High School Dress Code will be **strictly enforced.**
7. NO SEXUALLY EXPLICIT, DIRTY OR DANGEROUS DANCE BEHAVIOR WILL BE TOLERATED. Students engaging in this behavior will first be warned and a second offense will result in parent notification and student removal from the dance.
8. Morse High School is not responsible for any lost or stolen items. Please leave all valuable items at home.

**Proper behavior is expected at all times of all guests. Any violation of the provisions listed below will constitute grounds for non-admittance or dismissal from the dance and may result in school disciplinary action. NOTE: Anyone under the influence of alcohol or any other controlled substance will be denied entrance to the dance.
